You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Soort: Triodos Multi Impact Fund is a sub-fund of an open-ended investment company with variable capital.

Term: The fund has no maturity date. Triodos Investment Management is not entitled to terminate the fund unilaterally.

Objectives: The fund has sustainable investment as its objective as set out in article 9 of the SFDR. The fund qualifies as a 'fund of impact funds' that, through a number of Triodos funds, invests worldwide in a broad spectrum of impact themes, such as energy and climate, microfinance in developing countries, sustainable food and agriculture. The fund invests in investment funds that mainly provide loans. In addition, the fund invests approximately 30% of the fund's assets in Triodos Euro Bond Impact Fund, which invests in bonds issued by progressive green companies and democratic governments. The fund also invests to a limited extent in listed shares and private equity through the Triodos funds. The return of the fund is determined on the one hand by dividends received on the investments of the fund less the costs of managing the fund, and on the other hand by the value

changes of the investments. The return of the fund is therefore largely dependent on developments in the capital market, because the value of the fixed-income investment funds and impact bonds changes as a result of changing market interest rates. The fund is actively managed, but not in reference to any benchmark.

Intended retail investor: The fund is suitable for the retail and institutional investors who can afford to set aside capital for a long-term period. The investor is aware that they could lose some or all of their investment. Investing in the fund is suitable for the basic investor with a basic knowledge of the relevant financial markets and products as well as for the informed investor. The basic investor is able to make an informed investment decision based on the regulated and authorised offering documentation, or with the help of basic information provided by point of sale.

Orders to buy and sell shares are ordinarily processed daily. Capitalisation share classes reinvest the fund's net realised income, while distribution share classes may distribute it.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this

product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level. The product may be exposed to risks, such as interest rate risk, liquidity risk and sustainability risks. This product does not include any protection from future market performance so you could lose some or all of your investment.

As required by law for your protection, the fund's assets are held with a separate company, a depositary, so the fund's ability to pay out would not be affected by the insolvency of Triodos Investment Management. If the fund is terminated or wound up, the assets

will be liquidated and you will receive an appropriate share of any proceeds, but you may lose part or all of your investment. Your loss would not be covered by any investor compensation or guarantee scheme.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

Given the nature of the underlying investments of the fund and its objective of sustainable investment, a minimum holding period of 5 years is recommended. In general, the fund will invest in risk-bearing, most often non-listed, assets that are not liquid in the short term. In most cases, added value in the fund will be generated over the longer term. Thus, investments in the fund

require a long-term investment horizon of the investor.

You can redeem your investment daily. No redemption fees or penalties are charged at the level of the product. Redeeming your investment before the end of the recommended holding period may have a negative impact on the risk or performance of the product.
